FISCALLY SOUND BUDGET MAINTAINS ALL PROGRAMS AND SERVICES

PROPOSED BUDGET IS TAX-CAP COMPLIANT

On Tuesday, May 16, residents will head to the polls to vote on the proposed budget for the 2017-2018 school year. Totaling \$109,164,588, this proposal represents a 1.42 percent increase over the current year's adopted spending plan and carries a tax levy increase of 1.50 percent, which does not exceed the district's allowable tax levy limit.

Through careful planning, the Board of Education and district administrators developed a proposed spending plan that allows the district to preserve its wonderful academic, co-curricular and extracurricular programs. This budget proposal also includes the addition of two elementary teachers to stabilize class sizes.

Also on the ballot in May is Proposition 2, which seeks voter approval to expend an amount not to exceed \$1.4 million from the district's existing capital fund. The district plans to make various enhancements to the high school as well as districtwide ceiling and bathroom upgrades. The approval of this proposition will not have an impact on our taxpayers. The proposed budget retains the district's focus on technology enhancements and the programmatic needs that provide our students with the best education possible, balanced by our responsibility to remain fiscally accountable to our taxpayers. Furthermore, it allows for capital spending that will enable the district to make improvements to our facilities, as well as purchase two large buses and four rear axle vans.

The Board and administration have worked diligently to explore all possible efficiencies and ways to support both our students and our taxpayers. The budget that

Proposition II: Expend Capital Funds

The Board of Education seeks voter approval to expend an amount not to exceed \$1,400,000.00 from the district's existing capital fund. The use of these funds will not increase the proposed 2017-2018 budget or the tax levy, therefore resulting in no tax impact to our taxpayers.

An annual budget contains estimates of revenues and expenditures, and the actual financial results will differ from the budget. As noted by the Office of the State Comptroller, "A certain amount of the budget should be set aside for contingencies (either with a line item, or through the use of fund balances or reserves), to allow for the smooth operation of government in case of emergencies or minor errors in calculating revenues or expenditures." In the event that any surplus funds are available at the end of the fiscal year, the Board of Education will determine the best use of these funds, which may include using these funds to reduce taxes, maintain programs, fund the unappropriated, undesignated reserve as allowed by law at a maximum of 4 percent of the subsequent year's budget and/or fund other reserves.

FAQs

Q: What are a school district budget's main components?

A: There are two accounting segments that comprise the district budget — expenditures and revenues. Expenditures are calculated for



instruction, central services, transportation and other categories listed in the "Expenditures" chart. The district derives revenue to fund expenditures from the tax levy, state aid, payments in lieu of taxes (PILOTs) from Suffolk County for businesses operating in Deer Park, interest on account balances, BOCES reimbursements and related services as seen on the "Estimated Revenues" chart. The budget must be structured to balance expenditures with anticipated revenues.

Q: What is the difference between the tax levy and the tax rate?

A: The tax levy is the amount of money the Board of Education requests from the Town of Babylon in order to balance the budget after state aid and other revenues are taken into consideration. The tax rate is not set by the Board of Education. The town assessor calculates the assessed valuation of the properties in the Town of Babylon from which the tax rate is calculated. It is important to note that the tax levy limit applies only to the school district's tax levy, not the tax rate or an individual tax bill.

Q: What is a contingency budget?

A: Should voters defeat the proposed budget on May 16, the budget may be presented for one more vote prior to July. If the Board opts not to have a second vote, it can immediately adopt a contingency budget, which would force the district to operate with a zero percent tax levy increase under the state's tax cap law. If a second proposed budget is defeated, the district must, by law, adopt at zero percent.

VOTER INFORMATION

Voter Eligibility and Registration:

Deer Park residents are urged to vote in all school district elections. To cast your ballot in the May 16 budget vote and Board trustee election, you must be:

- A citizen of the United States.
- 18 years of age or older (we encourage eligible students to exercise their right to vote).
- A resident of the Deer Park School District for 30 days prior to vote.
- Registered to vote with the Suffolk County Board of Elections, or registered with the school district.

Registration is required if you have not voted within four years in a general election or school election. Registration will be held on:

- Tuesday, May 2, Administration Building, 9 a.m.-2 p.m.
- Thursday, May 4, Administration Building, 9 a.m.-2 p.m.
- Wednesday, May 10, John F. Kennedy Intermediate School, 4 p.m.-8 p.m.
