SELECTION / CLASS-IFICATION PROGRAM Upon a motion by Mrs. Elliott, seconded by Mr. Gouskos, the Board of Education unanimously approved the following Resolution:

WHEREAS, Section 135.4© (7) (ii) (a) (4) of the Regulations of the Commissioner of Education provides for a board of education to permit pupils in grades no lower than seventh grade to compete on interscholastic athletic teams organized for senior high school pupils, or senior high school pupils to compete on interscholastic athletic teams organized for pupils in the seventh and eighth grade; and

WHEREAS, these pupils are to be placed at levels of competition appropriate to their physiological maturity, physical fitness and skills in relationship to other pupils in accordance with the standards established by the Commissioner of Education, and

WHEREAS, the State Education Department issues the standards for these pupils to compete under a program called the Selection/Classification Program.

THEREFORE BE IT RESOLVED that the Deer Park Union Free School District Board of Education shall permit pupils to compete under the Selection/Classification Program in all sports.

Upon a motion by Mr. Wayne, seconded by Mr. Marino, the Board of Education adjourned at 8:40 p.m. and continued into a work session. Upon a motion by Mrs. Elliott, seconded by Mr. Gouskos, the Board of Education adjourned at 9:35 p.m.
